Toni Stegeman with Gilmore and Bell came to discuss the headworks and 2018 disinfectant financing. We are going to have to do two loans at the same rate of interest. The headworks will be by itself and then 2018 and 2014 will be a refinancing loan together. The closing costs will be more expensive but D.A. Davidson is going to pick up some of the cost. The City will be out \$10,000 for the closing and the cost to cover the survey of the headworks. Motion by Councilmember Chumbley second by Councilmember Crawford to table Bill No. 47. Motion carried.

### **NEW BUSINESS**

Craig Woycheese with Toth and Associates was present to discuss the electric rate study. He explained what the City would be getting for a rate analysis. He also gave an overview of the company.

Discussion was held concerning the new policy for net metering. City Administrator Urton said we are changing the credit that is given back from .10/Kwh to .03/Kwh. The ones that are on the .10/kwh will be grandfathered in so the new rate will be for the new net metering. Motion by Councilmember Briggs second by Councilmember Crawford to accept the new net metering policy. The following vote was taken. Ayes: Mlika, Crawford, Dolan and Smith. Nayes: Briggs, Fisher, Brewer and Chumbley. Mayor Crooks broke the time with a yes vote.

Motion by Councilmember Mlika second by Councilmember Briggs to accept the bid for wooden power poles from McFarland for \$10,701.00 Motion carried.

Motion by Councilmember Smith second by Councilmember Chumbley to accept the bid for Motorized gang operated air break switches from Border States for \$37,808.00. Motion carried.

Motion by Councilmember Crawford second by Councilmember Mlika to adjourn at 8:39 p.m. to closed session for personnel in accordance with RSMo. 610.021 (3). The following vote was taken. Ayes: Chumbley, Smith, Mlika, Crawford, Dolan, Briggs, Fisher and Brewer.
